

Mr. IENG Sary, through his Co-Lawyers (“the Defence”), hereby submits this expedited Request for an extension of time to file the Khmer translation of his Reply to the Co-Prosecutors’ Joint Response to Nuon Chea, Ieng Sary and Ieng Thirith’s Appeals against the Closing Order (“Reply”). This Request is made necessary due to the Interpretation and Translation Unit (“ITU”) being unable to translate the Reply by 6 December 2010,<sup>1</sup> the deadline set by the Pre-Trial Chamber.<sup>2</sup> ITU has stated that it will require 12 days to have the Khmer translation completed. Following the Defence’s internal review, the Khmer translation of the Reply will be ready to be filed by 22 December 2010.<sup>3</sup>

**WHEREFORE**, for all the reasons stated in this Request, the Defence respectfully requests the Pre-Trial Chamber to grant an extension of time to file the Khmer translation of Mr. IENG Sary’s Reply until 22 December 2010.
